# **CHAPTER 1: OFFICIAL BASKETBALL COMPETITIONS**

# **GENERAL PRINCIPLES**

- 1. FIBA has the authority to organise, sanction and control basketball competitions worldwide.
- 2. The Official Basketball Competitions are:
  - a. FIBA National Team Competitions;
  - b. FIBA Club Competitions;
  - c. FIBA 3x3 Competitions;
  - d. FIBA eSport Competitions;
  - e. FIBA-Recognised Competitions; and
  - f. FIBA Masters Competitions
- 3. The FIBA National Team Competitions are:
  - a. The FIBA Basketball World Cup;
  - b. The FIBA Basketball World Cup Qualifiers and Pre-Qualifiers:
  - c. The FIBA Women's Basketball World Cup;
  - d. The FIBA Women's Basketball World Cup Qualifying Tournaments and Pre-Qualifying Tournaments:
  - e. The FIBA Continental Cups;
  - f. The FIBA Continental Cup Qualifiers and Pre-Qualifiers;
  - g. The FIBA Women's Continental Cups;
  - h. The FIBA Women's Continental Cups Qualifying Events;
  - i. The Olympic Basketball Tournaments;
  - j. The FIBA Olympic Qualifying Tournaments, FIBA Women's Olympic Qualifying Tournaments, FIBA Olympic Pre-Qualifying Tournaments and FIBA Women's Olympic Pre-Qualifying Tournaments;
  - k. The FIBA U19 Basketball World Cup and the FIBA U19 Women's Basketball World Cup:
  - The FIBA U17 Basketball World Cup and the FIBA U17 Women's Basketball World Cup
  - m. All FIBA Continental Cups for Youth Categories (e.g. U20, U18, U16 etc.); and
  - n. All qualifying games and tournaments for the above competitions.

Any reference to the "main official competitions of FIBA" shall be understood as referring to the FIBA National Team Competitions and FIBA 3x3 Competitions.

Any reference to the "Competitions of FIBA" shall be understood as referring to the FIBA National Team Competitions, FIBA Club Competitions, FIBA 3x3 National Team Competitions and FIBA eSport Competitions.

- 4. The FIBA Club Competitions are all international club competitions organised by FIBA or its Regional Offices.
- 5. The FIBA 3x3 Competitions are defined and governed exclusively by the respective 3x3 regulations enacted by FIBA (National Team Competitions, World Tour, etc.).
- 6. FIBA-Recognised Competitions are all international leagues, cups, games and tournaments recognised by FIBA. For leagues, please refer to the relevant Internal Regulations governing



Leagues (Book 1, Chapter 3) or to the relevant Zone Regulations, as applicable. Recognised 3x3 competitions are governed exclusively by the respective 3x3 regulations enacted by FIBA.

- 7. FIBA Masters Competitions are age-group based international competitions organised by FIBA for players aged between thirty-five (35) and seventy-five (75) years old. FIBA Masters Competitions are defined and governed exclusively by the relevant FIBA Masters Regulations enacted by FIBA and/or by special Handbooks for the FIBA Masters Competitions that FIBA may enact from time to time to regulate the FIBA Masters Competitions in detail.
- 8. FIBA eSport Competitions are all international competitions organised by FIBA or its Regional Offices involving any electronic or virtual discipline of the sport of basketball. FIBA eSport Competitions are defined and governed exclusively by the relevant FIBA eSport Regulations enacted by FIBA and/or by special Handbooks for the FIBA eSport Competitions that FIBA may enact from time to time to regulate the FIBA eSport Competitions in detail.
- 9. All Official Basketball Competitions, except the FIBA 3x3 Competitions, FIBA eSport Competitions and FIBA Masters Competitions, shall be governed by the following provisions of general nature and any specific regulations applicable to the respective competitions. In case of discrepancy, the specific regulations shall prevail only if they have been approved by FIBA.
- 10. FIBA is competent to take any decision with respect to any Official Basketball Competition, including without limitation, imposing sanctions (Book 1, Chapter 6 Sanctions; Book 2, Chapter 6, article 2-101.c), restricting the participation in or removing teams from a competition, cancelling, relocating or postponing a competition or game(s) thereof, or withdrawing FIBA recognition, whenever a conflict or any other issue arises that, in FIBA's discretion, could reasonably jeopardise the reputation of FIBA, the sport of basketball, the integrity or successful staging of a competition, or the health, safety and/or security of the participants.
- 11. For FIBA National Team Competitions played under a home-and-away format, all home games must be played within the territory of the National Member Federation designated as the home team. In exceptional circumstances, such as health and safety concerns or as a result of disciplinary measures, FIBA may decide that a home game may be held in the territory of another National Member Federation.
- 12. The dates of all Official Basketball Competitions are defined in the FIBA Calendar. Other basketball competitions shall respect the FIBA Calendar (see article 1-1).



# CHAPTER 2: BIDDING TO HOST A FIBA NATIONAL TEAM COMPETITION

- 13. Following a bidding process, FIBA appoints one or more National Member Federations to organise a FIBA National Team Competition or a part thereof (hereinafter jointly referred to as "Competition"). FIBA may decide that it will directly organise the Competition. Subject to article 5-41 for continental competitions, the Central Board appoints the organiser of a Competition.
- 14. As part of the bidding process, FIBA shall:
  - a. Communicate the opening of the bidding process to National Member Federations and set a timeline and closing date for the bids;
  - b. Issue a "Host Nation Agreement" and/or a "Bid and Event Manual" and/ or a "Contract of Assignment" (hereinafter the "Hosting Documentation") specific to the particular Competition. The provisions of the Hosting Documentation shall prevail over the provisions of this Book 2 and shall be observed scrupulously; any bid submitted will imply a written undertaking to observe all the provisions of the Hosting Documentation with respect to the particular Competition:
  - c. Set up a transparent process for assessing the various bids and determining the successful bid; and
  - d. Require the successful bidder to sign the Hosting Documentation or any other form it may deem appropriate in FIBA's sole and reasonable opinion.
- 15. FIBA is the sole competent body entitled to define all of the requirements, rights and obligations issued for each Competition, including but not limited to:
  - a. The timetable of the bidding process;
  - b. The financial conditions;
  - c. The required government guarantees, including financial guarantees, where applicable;
  - d. The hosting requirements in regard to competition and practice venues, accommodation, transportation, etc.;
  - e. Any requirement concerning insurance, medical care and doping control; and
  - f. All necessary facilities and services to be provided.
- 16. The agreement to organise a Competition constitutes a contract between FIBA and the appointed National Member Federation (hereinafter the "Host"). All parties involved must scrupulously respect this contract.
- 17. The Host shall respect all provisions of these Internal Regulations and of the respective Hosting Documentation. In case of hosting games of the FIBA Basketball World Cup Qualifiers or Pre-Qualifiers, the FIBA Continental Cups Qualifiers or Pre-Qualifiers, the Host shall also respect all provisions of the registration form. Should the Host default on any of its engagements, FIBA shall have the right to:
  - a. Revoke the assignment of the organisation of the Competition; and/or
  - b. Impose disciplinary and financial sanctions on the Host; and/or
  - c. With or without recalling bids, assign the Competition to another National Member Federation that undertakes to respect all applicable provisions.
- 18. FIBA will use its best efforts to assist the Host. FIBA may require reimbursement from the Host of expenses incurred through providing such assistance.



# **CHAPTER 3: HOSTING A FIBA NATIONAL TEAM COMPETITION**

### RIGHTS AND DUTIES OF THE HOST

- 19. The Host has the right to propose any measures deemed necessary for the success of the Competition. Such measures shall be subject to approval by the FIBA Central Board and/or any other body as specified in the Hosting Documentation (e.g. Joint Management Committee). Furthermore, the Host must work closely and efficiently with all official bodies of FIBA responsible for the organisation of the Competition.
- 20. The Host shall ensure that all participating teams are treated equally. Special requests by any of the participating teams shall be forwarded to FIBA for approval.
- 21. The Host is entitled to rely on the close co-operation of the official bodies of FIBA and also of the participating teams and their National Member Federations.

#### **TECHNICAL PROVISIONS**

- 22. Hosts shall respect and apply the FIBA Official Basketball Rules, in particular the Appendix "Basketball Equipment".
- 23. Competitions shall be held only in venues that meet, in FIBA's reasonable opinion, the minimum requirements as provided for in the FIBA Official Basketball Rules and in the respective Hosting Documentation, using at all times and exclusively FIBA-approved technical equipment. The Host is responsible to ensure the proper maintenance and functioning of all equipment and facilities used for a Competition. FIBA may decide that the technical equipment for a Competition shall include an Instant Replay System (IRS), which shall meet FIBA's requirements and for which the Host shall bear all expenses.

## **COMPETITION DRAW**

- 24. The date, location and procedure for the draw of the Competition shall be decided by FIBA in accordance with the following provisions:
  - a. Unless otherwise decided in exceptional circumstances, the draw cannot take place until seventy-two (72) hours after the deadline for registration of teams;
  - b. The draw shall be held in a venue decided by FIBA after consultation with the Host, whether in the host country or in another location;
  - c. The involved National Member Federations must be informed by FIBA of the date and the place of the draw at least thirty (30) days in advance of the draw; and
  - d. An official representative of each National Member Federation whose team has qualified for the FIBA Basketball World Cup shall attend the draw. For all other Competitions such attendance at the respective draw is expected and strongly recommended.

# FLAGS AND ANTHEMS

- 25. During Competitions and draws, only flags and anthems of the countries or affiliated National Member Federations approved and recognised by FIBA may be used, in addition to the FIBA flag and the flag of the respective Competition, if any.
- 26. The flags shall be produced and placed in a manner that will be equal for all, in line with the respective Hosting Documentation and/or the FIBA Flag Manual.

#### PROTOCOL PROVISIONS

- 27. The highest representative of FIBA shall rank immediately after the highest authority of the host country.
- 28. At World-level Competitions, the order of precedence of the FIBA representatives shall be as follows:
  - a. The President;
  - b. The Secretary General;
  - c. The Secretary General Emeritus;
  - d. The Vice President;
  - e. The Deputy Secretary General or the delegate of the Secretary General, if any;
  - f. The Treasurer:
  - g. The members of the Executive Committee;
  - h. The members of the Central Board;
  - i. The Honorary Presidents and the honorary members;
  - j. The Chairman of each of the FIBA Commissions; and
  - k. The Presidents of the participating National Member Federations.
- 29. At Continental-level Competitions, the order of precedence of the FIBA representatives shall be as follows:
  - a. The FIBA President;
  - b. The FIBA Secretary General and/or FIBA Secretary General Emeritus;
  - c. The respective FIBA Zone President;
  - d. The Executive Director of the respective Regional Office;
  - e. The respective FIBA Zone Vice-President(s);
  - f. The respective FIBA Zone Board Members;
  - g. FIBA Central Board and Executive Committee members; and
  - h. Any other FIBA or FIBA Zone representative according to the respective FIBA Zone Order of Precedence.



#### ACCREDITATION FOR PARTICIPATING TEAM DELEGATIONS

- 30. FIBA and/or the Host shall allocate a maximum of twenty-five (25) accreditations for youth category competitions and twenty-eight (28) for senior category competitions (unless decided otherwise by FIBA) to each team delegation (hereinafter "Team Delegation"), but only twenty-one (21) of the Team Delegation Members may have access to the playing court. In addition, FIBA and/or the Host will allocate two (2) accreditations/VIP passes with access to the team areas, VIP tribune and hospitality area to each Team Delegation.
- 31. A sufficient number of seats must be reserved in a special tribune for all accredited participating Team Delegation members.

## **CEREMONIES**

- 32. The guidelines for opening and closing ceremonies as well as any other official function related to the Competition shall be specified for each FIBA Competition in the respective Hosting Documentation.
- 33. Any ceremony or official function organised by the Host shall be approved by FIBA.
- 34. If a new FIBA President is elected at the FIBA World Congress just before or during the FIBA Basketball World Cup, the outgoing President shall perform all of the official functions associated with the Competition, such as official opening ceremony, award presentation and Closing Ceremony.

#### MEDALS AND AWARDS

- 35. FIBA is solely responsible for developing and providing the official trophy of each Competition.
- 36. The Hosting Documentation may provide for the Host's obligation to design and/or produce medals (gold, silver, bronze) after prior written approval by FIBA. FIBA may retain the right in the Hosting Documentation to produce itself the medals. The minimum number of medals to be produced shall be specified in the respective Hosting Documentation.
- 37. Subject to approval by FIBA, the Host may produce additional awards, such as:
  - a. A diploma for each participating team, stating the final position of the team in the Competition:
  - b. A souvenir plaque or medal for each player, coach and/or member of the FIBA Officiating Team; and
  - c. Souvenirs for volunteers and staff.
- 38. The FIBA Officiating Team shall, under no circumstances, receive any awards other than as provided under article 2-.37.b above.

# **FINAL REPORT**

39. The Host shall submit to FIBA a comprehensive post-Competition report on its organisation as required in the respective Hosting Documentation.



# CHAPTER 4: PARTICIPATING IN A FIBA NATIONAL TEAM COMPETITION COOPERATION WITH FIBA AND THE HOST

- 40. National Member Federations participating with their team in a Competition shall cooperate closely with FIBA and the Host in order to ensure the technical and financial success of the Competition. In particular, National Member Federations shall meet all deadlines with regards to the registration of their participating team, players, coaches and additional accompanying delegation members. Any failure may result in sanctions, such as a fine or withdrawal of the right to participate in the Competition.
- 41. National Member Federations shall ensure that their teams facilitate the task of the Host, including by avoiding unnecessary expenses.

#### QUALIFICATION

- 42. Only qualified teams may take part in a Competition, unless provided otherwise in the specific regulations of a Competition. If required, FIBA may invite non-qualified teams to replace qualified teams that have withdrawn from a Competition or have been sanctioned by FIBA or are otherwise unable to participate. In principle, procedures of team replacement are provided for in the specific regulations of a Competition or in the respective Handbooks/Event Manuals. Where this is not the case, FIBA (or the Regional Office, as applicable) may extend an invitation at its discretion.
- 43. In order for a team to take part in a Competition, its National Member Federation must:
  - Be up-to-date in the payment of all fees due and owing to FIBA and/or its Regional Office;
  - b. Have no other debts due and owing to FIBA and/or its Regional Office that are more than ninety (90) days outstanding; and
  - c. Have participated in the relevant Qualifications leading to the Competition, subject to the specific regulations of the Competition.
- 44. In the event that a team that is not recognised by its National Member Federation, or whose national federation is not a member of FIBA or has had its membership suspended, takes part in a Competition without FIBA's approval, FIBA may decide that the Competition shall lose its official status and shall no longer be recognised by FIBA. National Member Federations shall refrain from participating in said Competition.

# **ELIGIBILITY OF PLAYERS**

45. The Internal Regulations governing the Eligibility and the National Status of Players apply to all Competitions (see Book 3, Chapter 1).

#### REGISTRATION

46. All National Member Federations whose teams have qualified or otherwise earned the right to take part in a Competition must submit to FIBA or to the appropriate FIBA body within the same deadline a registration form and a declaration of participation, as provided by FIBA. A failure to abide by the obligation to submit the above documentation may result in sanctions being imposed on the relevant National Member Federation.

# WITHDRAWAL OR FAILURE TO APPEAR

- 47. FIBA may impose sanctions on a National Member Federation that, after having sent its registration, cancels its participation or fails to participate in one or more games of the Competition or in any other official activity of the Competition (e.g. opening or closing ceremony, award ceremony etc.).
- 48. In addition to any sanctions imposed under articles 2-44 and 2-45, a National Member Federation that has qualified to participate in a FIBA Competition and has failed to register or has cancelled its participation or has failed to participate in the entire Competition is automatically banned from taking part in an official or friendly game for:
  - a. The thirty (30) days preceding the first day of the Competition for which it was qualified;
  - b. The duration of the Competition; and
  - c. The seven (7) days following the last day of the Competition.

# DUTIES OF THE PARTICIPATING NATIONAL MEMBER FEDERATIONS

- 49. Participating National Member Federations must respect the provisions of these Internal Regulations and any applicable regulations, guidelines and directives provided to the teams for each Competition. In the event of any violation, the appropriate FIBA body may impose sanctions (Book 1, Chapter 6 Sanctions; Book 2, Chapter 6, article 2-101.c). National Member Federations are strictly liable for the behaviour of all members of their Team Delegation, whether accredited or not, as well as for the behaviour of their accompanying persons and supporters.
- 50. A National Member Federation that has accepted an invitation to take part in a Competition by sending its registration form shall be obliged to take part.
- 51. Teams must be present at the site of the Competition in due time and must cooperate at all times with the Host and the FIBA representatives.
- 52. In particular, teams and/or Team Delegation members participating in a Competition may not under any circumstances:
  - a. Refuse to play a game, threaten to leave or leave the playing area during or before the end of a game;
  - b. Refuse to participate in, or leave before the end of, the opening ceremony and/or the award ceremony and the closing ceremony;
  - c. Disrupt the correct running of the Competition, official functions or ceremonies:
  - d. Violate the FIBA Code of Conduct (see article 1-93);
  - e. Violate the FIBA Internal Regulations governing Anti-Doping (Book 4);

- f. Refuse to participate in an official meeting; or
- g. Refuse to respect the Media Requirements (as per article 2-57).

#### **INSURANCE**

- 53. National Member Federations shall provide adequate insurance, as determined by FIBA, for all persons appearing on a Preliminary and/or Final Team Delegation roster (as relevant) or otherwise participating in any national team activity to cover all medical expenses (not covered by any insurance FIBA may provide pursuant to article 2-54) associated with the following circumstances::
  - a. Injury or illness that may occur during a time whilst the relevant person is participating in the national team activity (for players, during the entire Release Period as defined in Book 3 or during any time in which he or she is otherwise staying with the national team and for non-players, for the entire period during which the relevant person is staying with the national team), including during travel to and from the location of the national team activity; and
  - b. Injury or illness that may occur during a Competition and for which the Host is not responsible (e.g. sports injuries that are not due to equipment's malfunction or the Host's fault or negligence).
- 54. For certain Competitions, FIBA may offer limited insurance coverage to players on the Preliminary and/or Final Team Delegation Roster (as relevant) for the duration of the Competition and a preparation period defined by FIBA as set forth in the relevant handbook, competition regulations, circular letter, or other communication from FIBA.
- 55. When FIBA offers insurance as referenced in article 2-54, National Member Federations shall enter all information for any player participating in any national team activity as requested by FIBA in the FIBA Information System and ensure that any information entered is accurate and kept up to date. For the avoidance of doubt, FIBA may not provide insurance coverage for any player for whom complete and accurate information is not provided in the FIBA Information System.
- 56. If a National Member Federation fails to provide the information as required by article 2-55 for any of its players or otherwise fails to provide adequate insurance as set forth in article 2-53:
  - a. The National Member Federation shall be liable for any medical or other expenses incurred by that player that would have been covered by the insurance offered by FIBA; and
  - FIBA may determine the player is not eligible for Competitions of FIBA (see article 3-3)

#### MEDIA REQUIREMENTS

57. Participating National Member Federations and Team Delegation members shall respect the media requirements and deadlines in effect for the Competition, as outlined in Competitionspecific media requirements as set forth in the relevant Handbooks, guidelines and/or circulars related to the Competition and communicated in due time by FIBA to the participating National Member Federations.

58. For the avoidance of doubt, any violation of the media requirements set forth in article 2-57 shall in principle be an Administrative Offence, however, depending on the circumstances, FIBA may treat any such violation as a Disciplinary Offence (see also articles 1-165 and 1-175).



# **CHAPTER 5: TEAM UNIFORMS**

[Note - These Regulations are valid for all FIBA National Team Competitions. National Member Federations are encouraged to use them in their entirety at national level].

# **GENERAL PROVISIONS**

- 59. Advertising on game/playing uniforms, warm-up shirts and tracksuits must be identical for all players of a team.
- 60. The manufacturer's trademark (logo) on uniforms, warm-up shirts, tracksuits and Team Delegation uniforms (if applicable) must be the same.
- 61. The country/badge/name symbol may be integrated as part of the design of the uniforms (playing shirts, shorts, tracksuits, warm ups, socks), subject to FIBA approval.
- 62. The two sets of game/playing uniform (home and away) must differ only in colour and shall bear the same markings, including identical advertising message(s) (size and sponsor) and manufacturer's trademark (logo). The two sets of game/playing uniforms may differ in design from each other, subject to FIBA approval, so long as each set bears the same markings (identical advertising messages and manufacturer's trademark, etc.)
- 63. Advertising of the team's sponsors is permitted in maximum three (3) different advertising spaces:
  - a. On the front of the playing shirts;
  - b. On the back of the playing shirts; and
  - c. On the right leg of the shorts.
- 64. A maximum of four (4) sponsorship messages are allowed on the game/playing uniform. The same sponsor can appear on a maximum of two (2), out of the four (4) available, advertising messages' spaces.
- 65. A maximum of three (3) sponsorship messages are allowed on the warm up shirts and tracksuits. The sponsorship messages may be different from those that appear on the game/playing uniform but the sponsorship message on the warm up shirt and tracksuit top must be identical.
- 66. All advertising is subject to the same restrictions set out for advertising in Book 1 of these Internal Regulations.
- 67. Areas of applicable markings are measured by multiplying the maximum height by the maximum length of the marking (e.g. advertising / manufacturer logo).
- 68. At least thirty (30) days prior to the starting date of the Competition, National Member Federations must submit to FIBA for approval a drawing/design of the complete team uniform set that will be worn during the Competition. Designs can be sent by mail or email, or through a special platform that may be created for this purpose by FIBA.


- 69. The uniforms to be worn by the team during the Competition shall be identical to the submitted drawing/design or pre-production sample, and will be verified prior to the starting date of the Competition at the Technical Meeting. Once approved at the Technical Meeting, no changes may be made to any of the team uniforms, including in regard to advertising.
- 70. All players shall be uniformly dressed during the team presentation in a Competition (for example, during the team introduction and national anthems).
- 71. Failure to comply with any article in this Chapter 5 shall in principle be an Administrative Offence, however, depending on the circumstances, FIBA may treat any such violation as a Disciplinary Offence (see also articles 1-165 and 1-175), including without limitation in cases involving repeat or multiple violations.
- 72. During FIBA Competitions, participating National Member Federations are solely responsible for ensuring that their uniforms respect all laws applicable to the place of the Competition. For the avoidance of doubt, in giving approval pursuant to articles 2-68 and 2-69, FIBA does not guarantee compliance with applicable laws and accepts no liability whatsoever in that regard.
- 73. During the Olympic Games, the participating players, coaches, officials and accompanying persons must respect the Olympic Charter and any other rule or guideline (including without limitation regarding advertising) issued by the International Olympic Committee. In case of discrepancy between such provisions and these Internal Regulations, the former shall prevail.

# **PLAYING SHIRTS**

- 74. Playing shirts must conform to the Official Basketball Rules.
- 75. The front of the playing shirt shall conform to the following provisions and the diagram below:
  - a. The manufacturer's trademark (logo) may appear once, provided that it occupies an area of maximum twenty (20) cm<sup>2</sup>;
  - b. Any logo provided by FIBA, including without limitation, the FIBA Competition logo (portrait version) and/or other additional logo (for example, a winner's badge) must appear on the front of the playing shirt, unless FIBA provides other instructions as to the placement. The size of any such logo may change at FIBA's discretion;
  - c. The player's number must appear and be clearly visible. It must have a height of minimum eight (8) cm and must be placed below the country name or badge, at a distance of four (4) cm. Any other markings on the front of the playing shirt must be at a distance of minimum four (4) cm from the player's number;
  - d. The country name or IOC code must appear, and an additional country badge/symbol may appear, on the front of the playing shirts as follows:
    - i. Above the player's number;
    - ii. For the country name or IOC code, if the written text comprises one (1) line, the letters shall be of maximum eight (8) cm in height; if the written text comprises two (2) lines, the letters on each line shall be of maximum six (6) cm in height. In case of doubt or controversy regarding the name of the country to appear on the uniform, FIBA shall decide;
    - iii. The country badge/symbol must occupy an area of maximum twenty (20) cm<sup>2</sup> and shall be placed in the middle of the chest, between the FIBA logo and the manufacturer logo. For the avoidance of doubt, the country badge/symbol cap



- only be the country flag or the country crest. In case of doubt or controversy regarding the badge/symbol of the country to appear on the uniform, FIBA shall decide; and
- iv. Any additional logo provided by FIBA (for example, a winner's badge) that replaces the country badge/symbol shall be placed in the middle of the chest, between the FIBA/Competition logo and the manufacturer logo, unless FIBA provides other instructions as to the placement of any logo provided by FIBA pursuant to article 2-75.b
- e. The National Member Federation badge/symbol may appear, but must occupy an area of maximum twenty (20) cm<sup>2</sup>; and
- f. Advertising of one (1) sponsor is permitted as follows:
  - i. The written text or the sponsor's logo must occupy an area of maximum three hundred and twenty (320) cm<sup>2</sup>; and
  - ii. The advertising must be placed below the player's number.



- 76. The back of the playing shirt shall conform with the following provisions and the diagram below:
  - a. The player's name (surname or preferred name) must appear above the player's number and shall comprise only one (1) line of text. The height of the writing must be of minimum five (5) cm and maximum eight (8) cm. No two (or more) players on the same team may have identical names on their uniforms. In case of doubt or controversy regarding the name of the player to appear on the uniform, FIBA shall decide;
  - b. The player's number must appear and be clearly visible; it shall have a height of minimum sixteen (16) cm; any other markings on the back of the playing shirt must be at a distance of minimum four (4) cm from the player's number;




c. Advertising is permitted provided that it occupies an area of maximum three hundred and twenty (320) cm<sup>2</sup>. The advertising space shall be used as follows:

Option 1: in one (1) block of maximum three hundred and twenty (320) cm<sup>2</sup> with one (1) sponsor's written text or logo; or

Option 2: split into two (2) different sponsors'; or written text or logos, provided that the combined total size does not exceed three hundred and twenty (320) cm<sup>2</sup>

In both options, any advertising logo(s) must be placed below the player's number; and

d. No other marking is permitted on the back of the playing shirt.




# **PLAYING SHORTS**

- 77. Playing shorts must conform to the Official Basketball Rules (article 4.3).
- 78. Playing shorts shall conform to the following provisions and the diagram below:
  - a. The manufacturer's trademark (logo) may appear once, provided that it occupies an area of maximum twenty (20) cm<sup>2</sup>;
  - b. Advertising of only one (1) sponsor is permitted on the front of the shorts, on the right leg as per diagram below, provided that the sponsor's written text or logo occupies an area of maximum one hundred (100) cm<sup>2</sup>;



- The sponsor advertised may be different from those advertised on the playing shirt;
- d. No other markings may be placed in this area;
- e. For the avoidance of doubt, the player's number is not permitted on the shorts;
- f. The country badge/symbol or National Member Federation crest may also appear once on the shorts on the left leg opposite the sponsor's messages (if any) and must occupy an area of maximum twenty (20) cm<sup>2</sup>; and
- g. The country name may be integrated as part of the design of the shorts, subject to FIBA approval.



# **PLAYING SOCKS**


- 79. Playing socks shall conform to the following provisions:
  - a. The manufacturer's trademark (logo) may appear, provided that it occupies an area of maximum twenty (20) cm<sup>2</sup>; and
  - b. Advertising or any other commercial logo is prohibited.

# WARM-UP SHIRTS

- 80. Warm-up shirts shall conform to the following provisions and the diagram below:
  - a. The manufacturer's trademark (logo) may appear once on the front of the warm-up shirts, provided that it occupies an area of maximum twenty (20) cm<sup>2</sup> and is identical (same size, place etc.) to the manufacturer's trademark (logo) on the front of the playing shirt:
  - b. The country name or IOC code must appear on the front of the warm-up shirts and be identical (same size, place etc.) to the country name or IOC code on the front of the playing shirt. The country name or IOC code may appear on the back as a replacement of the player's name (size 1 line: max 8 cm in height and 2 lines: max 6 cm in height). In case of doubt or controversy regarding the country name to appear on the uniform, FIBA shall decide:
  - c. An additional country badge/symbol or National Member Federation badge/symbol may appear twice on the front, sleeves or back of the warm-up shirt (only once in either




- of these locations) and must occupy an area of maximum twenty (20) cm<sup>2</sup>. If the country badge/symbol or National Member Federation badge/symbol appears on the back, it must be positioned above the player's name. For the avoidance of doubt, the country badge/symbol can be the country flag or country crest. In case of doubt or controversy regarding the badge/symbol of the country to appear on the uniform, FIBA shall decide;
- d. The player's name (surname or preferred name) may appear on the back of the warmup shirt, provided that it is identical (same size and same place) to the player's name on the back of the playing shirt. In case of doubt or controversy regarding the name of the player to appear on the uniform, FIBA shall decide; and
- e. Advertising is permitted as follows:
  - On the front of the warm up shirts: the size of the advertising space must be identical to that of the playing shirts, but the sponsor may be different to that of the playing shirts. However, the advertising must be identical (same sponsor, logo, design) to that of the tracksuits;
  - ii. On the back of the warm up shirts: the size of the advertising space must be identical to that of the playing shirts, but the sponsor(s) may be different to those of the playing shirts. However, the advertising must be identical (same sponsor(s), size, logo, design) to that of the tracksuits.







#### **TRACKSUITS**

- 81. Tracksuits shall conform to the following provisions and the diagrams below:
  - a. The manufacturer's trademark (logo) may appear once on tracksuit top and once on trousers, provided that it occupies an area of maximum twenty (20) cm<sup>2</sup> on each piece of tracksuit;
  - b. The country name or IOC code must appear on the front and may also appear additionally on the back of the tracksuits and be identical (same size, place etc.) to the country name or IOC code on the front of the playing shirt. If the country name or IOC code appears on the back, it must replace the Player's name (size 1 line: max eight (8) cm in height and 2 lines: max six (6) cm in height). In case of doubt or controversy regarding the country name to appear on the tracksuits, FIBA shall decide;
  - c. An additional country badge/symbol or National Member Federation crest may appear twice on the front, sleeves or back of the tracksuit top and must occupy an area of maximum twenty (20) cm² (only once in either of these locations). If the country badge/symbol or National Member Federation crest appears on the back, it must be positioned above the player's name. The country badge/symbol or National Member Federation crest may also appear on the trousers and must occupy an area of maximum twenty (20) cm². For the avoidance of doubt, the country badge/symbol can be the country flag or country crest. In case of doubt or controversy regarding the badge/symbol of the country to appear on the uniform, FIBA shall decide;
  - d. The player's name (surname or preferred name) may appear on the back of the tracksuit, provided that it is identical (same text, size, place etc.) to the player's name on the back of the playing shirt. In case of doubt or controversy regarding the name of the player to appear on the uniform, FIBA shall decide;
  - e. Advertising is permitted as follows:
    - i. On the front of the tracksuits: the size of the advertising space must be identical to that of the playing shirts and be a size of maximum three hundred and twenty (320) cm² (as per the front of the playing shirt); but the sponsor may be different to that of the playing shirts. However, the advertising must be identical (same sponsor, logo, design) to that of the warm up shirts; and
    - ii. On the back of the tracksuits: the size of the advertising space must be identical to that of the playing shirts, but the sponsor(s) may be different to those of the playing shirts. However, the advertising must be identical (same sponsor(s), size, logo, design) to that of the warm up shirts; and





f. When the front part of the tracksuit has a zipper, the country flag or country name must appear on the front. Should the country flag appear on the front of a tracksuit with a zipper, the country name shall replace the player's name on the back. The rest of the above provisions shall apply in conjunction with the special design below, subject to FIBA approval.



#### **PLAYING SHOES**

- 82. Playing shoes shall conform to the following provisions:
  - a. The manufacturer's trademark (logo) may appear; and
  - b. Advertising is prohibited.

# **ACCESSORIES**

- 83. All accessories must conform to the Official Basketball Rules (article 4.4).
- 84. The following provisions shall apply to eyewear, wristbands, headgear, headbands, knee braces, knee pads, arm and leg compression garments, and to any other accessories permitted under the Official Basketball Rules:
  - Advertising or any other commercial logo is prohibited; and



- b. The manufacturer's trademark (logo) is permitted, provided that it occupies an area of maximum twelve (12) cm<sup>2</sup>.
- 85. No advertising or manufacturers' trademark (logo) is allowed on all other accessories.

#### **TEAM DELEGATION UNIFORMS**

- 86. All other Team Delegation members who are entitled to sit on the team bench during the game must be dressed in a neat and presentable manner that appropriately represents their respective national member federation and the sport of basketball, in accordance with the following guidelines:
  - a. Head coaches and assistant coaches do not need to dress in a uniform manner, but shall be neatly dressed, wearing business or smart casual attire, as follows:
    - i. Dress jacket, sport coat/blazer, sweater, collared dress shirt, quarter-zip top or polo-shirt (short or long-sleeved). T-Shirts, blouses or other non-collared shirts under a dress jacket, sport coat/blazer are allowed if the outer layer is worn at all times. Any shirt in male- or unisex-style shall be tucked in at all times; and
    - ii. Dress trousers, slacks or skirt; and
    - iii. Dress shoes or casual shoes (i.e. not athletic shoes).
    - iv. Smart or business casual dresses are permitted.
  - b. All other Team Delegation Members must be uniformly dressed and shall wear neat casual or athletic casual attire, as follows:
    - Dress jacket, sport coat/blazer, sweater, dress shirt, blouse, tracksuit top, quarter-zip top or polo-shirt (short or long-sleeved). Any shirt in male- or unisexstyle shall be tucked in at all times;
    - ii. Dress trousers, slacks or tracksuit bottoms; and
    - iii. Dress shoes or casual shoes.
  - c. The following is prohibited for any Team Delegation Member
    - Jeans of any kind, bermuda-pants or shorts, athletic or activewear (with the exception of tracksuit bottoms which are authorized for physiotherapists and trainers as set forth in 2-86b.ii., above), jogging pants, jumpsuits, sweatpants, or sport leggings;
    - ii. Sweatshirts and hoodies, or singlets;
    - iii. Torn, revealing or ripped clothing, or denim shirts or jackets;
    - iv. Athletic shoes, basketball shoes, work boots, sandals, flip-flops, or similar; and
    - v. Hats, caps or beanies of any kind.
  - d. Any variations to the above must be approved by FIBA in writing in advance, and will only be approved if, in FIBA's sole discretion, the variation conforms with the spirit of this article.
- 87. Upon FIBA's prior written approval, the following items are permitted on the clothing of the Team Delegation Members:
  - a. The manufacturer's trademark (logo) may appear once, provided that it occupies an area of maximum twenty (20) cm<sup>2</sup>;
  - b. Advertising, provided that the advertising is identical to that on the team's uniforms;
  - c. The country name and/or badge symbol.



# **CHAPTER 6: OTHER COMPETITION ASPECTS**

## REGISTRATION OF TEAM DELEGATION MEMBERS

88. Registration of players, coaches and other accompanying Team Delegation members in a Competition shall comply with the provisions of Book 3 of these Internal Regulations.

#### **TECHNICAL MEETING**

- 89. A Technical Meeting with the Team Delegations shall be held at the latest one (1) day before the start of each Competition and shall be chaired by the highest-ranked FIBA representative (or the delegate of the highest-ranked FIBA representative).
- 90. Unless otherwise specified in specific Competition regulations, the Technical Meeting shall be held for the following purposes:
  - a. For Team Delegations to officially submit the Final Team Delegation Roster (see articles 3-137 et seq.) as follows:
    - i. A list of the maximum twelve (12) players, and their uniform numbers, as well as the required personal details and passports for each player;
    - ii. A list of the maximum thirteen (13) (unless decided otherwise by FIBA, see article 2-30) FIBA-approved accompanying Team Delegation members (including coaches), as well as the required personal details and passports for each of the FIBA-approved accompanying Team Delegation members; and
    - iii. The Entry Form provided by FIBA, fully completed and duly signed.
  - b. For FIBA, represented through a FIBA Technical Delegate or FIBA Commissioner:
    - i. To verify the final Team Delegation composition as well as the players', coaches' and accompanying Team Delegation members' passports;
    - ii. To verify that the game uniforms (in light and dark colour), warm-up uniforms and any other garment fully reflect the samples and/or designs pre-approved by FIBA;
    - iii. To verify that the other Team Delegation members respect the requirements set forth in article 2-86.
    - iv. To brief Team Delegations on all organisational aspects of the Competition and related procedures and outline the expectations in regard to the teams' participation.
- 91. FIBA shall send to each participating National Member Federation a written invitation (notification by email is also valid) to the Technical Meeting. The invitation shall contain:
  - a. Date, time and location of the Technical Meeting;
  - b. Number and role of the Team Delegation members who are required to attend;
  - c. Agenda of the Technical Meeting; and
  - d. A detailed list of the documents and materials that each Team Delegation is required to bring to the Technical Meeting.
- 92. Once the Technical Meeting is declared closed, no changes to the composition of the final roster (twelve (12) players), including team uniform numbers, can be made at any time during the Competition. FIBA may enact specific regulations for the FIBA Basketball World Cup Qualifiers or other Competition.

93. Once the Technical Meeting is declared closed, FIBA may officially communicate the final rosters to the public.

#### **CLASSIFICATION OF TEAMS**

94. The classification of teams shall be made according to the FIBA Official Basketball Rules, Chapter D – Classification of Teams.

# **DOPING CONTROLS**

95. Doping control tests may be carried out in accordance with the Internal Regulations governing Anti-Doping (see Book 4) at any Official Basketball Competition or out-of-competition.

# **VIOLATIONS**

- 96. The FIBA Technical Delegate or the FIBA Commissioner shall verify the compliance with the Internal Regulations at each game of the respective Competition and shall report without delay to FIBA any violations. Any third person is allowed to bring violations to the attention of FIBA.
- 97. In addition to the provisions of this Book 2, the procedure set out in these Internal Regulations (Book 1, Chapter 6 Sanctions & Chapter 7 Procedural Provisions) shall apply. In case of discrepancy, the former shall prevail.

#### **PROTESTS**

98. The protest procedure shall be made according to the FIBA Official Basketball Rules, Chapter C – Protest Procedure.

# **TECHNICAL COMMITTEE**

- 99. A Technical Committee may be formed at the beginning of each Competition. It shall consist of three (3) persons, namely the Secretary General or the Secretary General's representative, who shall be chairman of the Committee, a delegate of the Host and a third member selected by them.
- 100. If the Competition is organised in different cities, there shall be an equivalent number of Technical Committees.
- 101. The functions of the Technical Committee, which shall terminate with the announcement of the final classification of the Competition or after the last game in a city, as determined by FIBA, are as follows:
  - a. Approval of the final score of each game and the final classification of the Competition;
  - b. Examination and decision on protests in the first instance;



- c. Imposition of sanctions against players, coaches, assistant coaches, Team Delegation members, FIBA Commissioners, FIBA Referees, FIBA Table Officials and FIBA Statisticians who have violated the spirit and/or the letter of the FIBA Code of Conduct (see article 1-93), (including, without limitation, the FIBA General Statutes and the FIBA Internal Regulations, and in particular the FIBA Code of Ethics and Integrity (articles 1-117 to 1-156) and the FIBA Code of Fair Play (articles 1-104 to 1-107). Sanctions imposed shall be based upon the reports submitted by the FIBA Commissioners and Referees, as well as on observations by members of the Technical Committee. Facts ascertained in such FIBA Commissioner or Referee reports are deemed to be accurate. Any party may prove their inaccuracy on a balance of probabilities, in which case the burden of proof shall revert to FIBA; and
- d. Decisions concerning any other unsportsmanlike behaviour and/or rule violation that may occur during the Competition.

# JURY OF APPEAL

- 102. A Jury of Appeal may be formed at the beginning of each FIBA Competition.
- 103. The Jury of Appeal shall be presided over by a Chairman and will further consist of four (4) members and a maximum of four (4) substitute members, all of whom are appointed by the Technical Committee from among representatives of participating National Member Federations.
- 104. The Jury of Appeal Chairman shall be the FIBA President or the most senior member of the FIBA Central Board present (regardless if such person is anyhow connected with a team taking part in the Competition or not), unless a Chairman is appointed by a competent body (see the Regulations governing Appeals in Book 1, Chapter 8).
- 105. Should the FIBA President or other members of the Central Board not be present and should there not be a Chairman otherwise appointed (see article 2-104), there shall be five (5) appointed members, one (1) of whom shall be elected by the other members of the Jury of Appeal to preside over the Jury of Appeal.
- 106. In Competitions involving a maximum of six (6) teams, the Jury of Appeal shall be composed of a Chairman with two (2) appointed members and two (2) substitute members.
- 107. Members of the Jury of Appeal having a connection with teams involved in a dispute shall not sit on the jury and must be replaced by substitute members. The Chairman of the Jury of Appeal shall be replaced, if necessary, by a person appointed by the Chairman with the approval of the Technical Committee that will be responsible for making the formal announcement.
- 108. The function of the Jury of Appeal is to examine and to decide in second instance appeals against decisions taken by the Technical Committee concerning the approval of game results and sanctions imposed. Its decisions with respect to game results are final and cannot be appealed further.

# SAFETY AND SECURITY MATTERS

- 109. FIBA may appoint one or more persons or entities with experience in law enforcement and event organisation as Security Adviser(s). The Security Adviser(s) shall, either individually or collectively, and upon FIBA's request:
  - perform inspection visits at Competition venues as well as any other location to be used for the purposes of a Competition;
  - b. prepare risk assessment reports in relation to a Competition;
  - c. advise FIBA on any measures required for safety and security in a Competition; and
  - d. co-operate with the Host in implementing safety and security measures.
- 110. The Host shall strictly comply with the safety and security requirements of the Hosting Documentation and take any other or further measures required to ensure the safety and security of the team delegations, officials and spectators. FIBA, after consultation with the Security Adviser (as relevant) and depending on the circumstances of each case, may issue binding instructions to the Host and/or require guarantees, failing which it may decide to take any measures deemed appropriate in FIBA's sole discretion, including without limitation to cancel, postpone (fully or partially) the Competition, play on neutral ground/a neutral venue (at the cost of the Host), or to unilaterally exercise its rights under article 2-11 or 2-15.
- 111. The Host shall ensure that the playing area, spectators' area, team changing rooms, and referee changing rooms shall have a temperature between 16°C and 28°C.

# **GAMES BEHIND CLOSED DOORS**

- 112. The following provisions apply to games played behind closed doors in connection with a sanction (see, for example, article 1-172) or in any other circumstances.
- 113. Unless the competent FIBA body decides otherwise, no one may attend a game played behind closed doors, with the exception of:
  - a. the maximum number of people per team delegation, including the players, as set forth in article 2-30;
  - b. a number of persons holding valid media accreditations, not to exceed the number of issued accreditations during the previous home game;
  - a number of persons holding accreditations for the host broadcaster, not to exceed the average number of issued accreditations during the previous International Window Periods;
  - d. police officers and security staff that are assigned specific tasks related to security at the relevant game;
  - e. a maximum number of people carrying out functions related to event delivery and the arena infrastructure, as defined by FIBA;
  - f. a maximum of fifteen (15) FIBA representatives (including, for example, FIBA Referees, the FIBA Technical Delegate, the FIBA Broadcast Operations Venue Manager, FIBA Photographers, FIBA Security Advisor, etc.); and
  - g. a maximum of fifty (50) representatives of FIBA Commercial partners, provided that attendance requests are submitted and approved by FIBA at least two (2) weeks in advance of the game (or as required by FIBA's written instructions).

- 114. The Host shall also observe the following provisions:
  - a. The game shall take place in a venue registered within the relevant deadlines and approved by FIBA and/or its Regional Office;
  - b. The venue shall fulfil the requirements of the applicable regulations (including, Competition Regulations, FIBA Internal Regulations, any applicable Handbook, Circular Letter and other official documents or decisions of FIBA), including with respect to branding, TV production, services and protocol obligations;
  - c. The Host shall provide the visiting team and the FIBA Game Officials all services as reasonably requested for the Competition (e.g. local transportation, access to training facilities, inspection visit, etc.);
  - d. The Host shall provide a tentative list of all persons in attendance as set forth in article 2-113, including last name, first name, functions, photo at the latest seven (7) days before the game, unless provided otherwise; and
  - e. The Host shall submit the final list at the Technical Meeting prior to the game for approval by the FIBA Technical Delegate;

# **CHAPTER 7: SPECIAL COMPETITION PROVISIONS**

115. This Chapter complements the provisions set out in the Chapters 1 to 6 of this Book. In the case of discrepancy, the provisions of this Chapter shall prevail. In case of matters not regulated in the Internal Regulations or in the Hosting Documentation, FIBA shall decide on an ad-hoc basis.

# FIBA BASKETBALL WORLD CUP

- 116. The FIBA Basketball World Cup shall be held every four (4) years (2027, 2031, 2035, etc.). Unless otherwise decided by the Central Board, the FIBA Basketball World Cup shall have a minimum duration of sixteen (16) days.
- 117. Thirty-two (32) teams, representing all continents, are eligible to participate in the FIBA Basketball World Cup as follows:

The Host of the Final Round shall be directly qualified. Any other Host(s) shall only directly qualify if the Central Board so decides. If granted, the spot(s) will be deducted from the relevant continental quota.

- 118. In the event a qualified team withdraws, is suspended or, in FIBA's sole determination, is not able for any reason to participate, FIBA has the right to invite the best non-qualified team that participated in the FIBA World Ranking from the same continent that participated in the FIBA Basketball World Cup Qualifiers, to replace it. If the replacement team or a second qualified team are, in FIBA's sole determination, not able to participate for any reason, FIBA may issue an invitation to another team at its discretion and/or reduce the number of teams in the FIBA Basketball World Cup and adjust the competition format and schedule accordingly. This procedure may be applied more than once.
- 119. Registration forms for participation in the FIBA Basketball World Cup must be sent by FIBA to the qualified National Member Federations reasonably in advance prior to the starting date of the Competition.
- 120. National Member Federations must submit the duly completed and signed registration forms by the deadline set by FIBA. In the event that a qualified National Member Federation fails to meet this deadline, FIBA may revoke this National Member Federation's right to participate and replace it in accordance with article 2-118.

- 121. The following system of competition shall apply for the FIBA Basketball World Cup. Group Phase First Round

#### FIBA BASKETBALL WORLD CUP QUALIFIERS - GENERAL PROVISIONS

- 122. The FIBA Basketball World Cup Qualifiers shall be held during the period of two (2) years before a FIBA Basketball World Cup (2025-2027, 2029-2031, 2033-2035, etc.).
- 123. The FIBA Basketball World Cup Qualifiers shall take place during six (6) International Window Periods, in line with the FIBA Calendar.
- 124. Participation in the FIBA Basketball World Cup Qualifiers shall comply with the provisions specific for each continent as defined in these Internal Regulations.
- 125. In the event a qualified team withdraws, is suspended or, in FIBA's sole determination, is not able for any reason to participate, FIBA has the right to invite the best non-qualified team in the FIBA World Ranking from the same continent, to replace it. If the replacement team or a second qualified team are, in FIBA's sole determination, not able to participate for any reason, FIBA may issue an invitation to another team at its discretion and/or reduce the number of teams in the FIBA Basketball World Cup Qualifiers and adjust the competition format and schedule accordingly. This procedure may be applied more than once.
- 126. Together with the invitation to National Member Federations to register for the FIBA Basketball World Cup Qualifiers, FIBA shall:
  - Issue the applicable FIBA Basketball World Cup Qualifiers National Member Federations Handbook (hereinafter "WCQ Handbook"). In case of discrepancy or conflict between the provisions of such documents and of the Internal Regulations, the latter shall prevail;
  - b. Set a timeline and closing date for registrations;
  - c. Set up a transparent process for assessing whether National Member Federations fulfil the criteria set out in the FIBA General Statutes, the FIBA Internal Regulations and the WCQ Handbook and are therefore entitled to register; and

- d. Issue the standard registration forms, by which each National Member Federation accepts the obligations associated with its registration to the FIBA Basketball World Cup Qualifiers, reasonably in advance prior to the starting date of the FIBA Basketball World Cup Qualifiers.
- 127. The duly completed and signed registration forms must be received by FIBA no later than thirty (30) days prior to the draw of the FIBA Basketball World Cup Qualifiers. In the event that a qualified team fails to meet this deadline, FIBA may revoke this National Member Federation's right to participate and replace it in accordance with article 2-118.
- 128. FIBA may require games that could influence the qualification of other teams to be played on the same day and at the same time.
- 129. Participating National Member Federations shall comply with the WCQ Handbook and the following articles.
- 130. Games may be played only in venues that have been inspected, registered and approved in accordance with the WCQ Handbook and approved by FIBA. The venue of each game shall be selected by the Host concerned and shall be communicated to FIBA according to the deadlines defined in the WCQ Handbook. All basketball equipment shall comply with the Official Basketball Rules Basketball Equipment. Wooden floors shall not display any advertising or graphic elements other than those allowed in the FIBA Internal Regulations and/or Handbook or otherwise approved by FIBA.
- 131. The Host of a WCQ shall appoint a National Member Federation game director in compliance with FIBA guidelines.
- 132. Thirty (30) days before the draw of the FIBA Basketball World Cup Qualifiers, and in order to be registered and approved in accordance with the FIBA Basketball World Cup Qualifier National Member Federations Handbook, each National Member Federation must submit a list with a minimum of one (1) approved venue for the FIBA Basketball World Cup Qualifiers cycle.
- 133. The Host shall cover all organisational costs as per the WCQ Handbook.

# FIBA BASKETBALL WORLD CUP PRE-QUALIFIERS

134. As a general principle, all teams qualified to participate in the FIBA AfroBasket (sixteen [16] teams) for the African Region or the FIBA Asia Cup for the Asian Region (sixteen [16] teams), unless the Host of the FIBA Basketball World Cup is not among those teams (see article 2-140) are automatically qualified for the following FIBA Basketball World Cup Regional Qualifiers. No FIBA Basketball World Cup Pre-Qualifiers will be organised for those regions.

For the Americas and Europe Zones, all teams qualified for the FIBA AmeriCup (twelve [12] teams) or FIBA EuroBasket (twenty-four [24] teams) shall be automatically qualified for the following FIBA Basketball World Cup Qualifiers. Additional FIBA Basketball World Cup Pre-Qualifiers shall be organised to qualify four (4) teams for the FIBA Basketball World Cup Americas Qualifiers and eight (8) teams for the FIBA Basketball World Cup European Qualifiers through regional Pre-Qualifiers rounds.

- 135. As such, all registered National Member Federations that are not qualified to participate in their respective FIBA Continental Cups Qualifiers in Europe and Americas shall play home and away games in the International Window Periods for the FIBA Basketball World Cup Pre-Qualifiers.
- 136. All FIBA Basketball World Cup Pre-Qualifiers games shall be played according to the relevant regulations.
- 137. FIBA Basketball World Cup Americas Pre-Qualifiers
  - The FIBA Basketball World Cup Americas Pre-Qualifiers shall be played in two (2) rounds.

Each team shall play home and away games against the other teams in its group (a total of six [6] or four [4] games for each team). In the event that home and away games are not possible to organise due to logistical or other reasons, the group(s) shall be played in a tournament format, hosted by one (1) of the participating National Member Federations, and according to the specific system of competition approved by FIBA.
    - iii. The four (4) highest-placed teams shall qualify for the FIBA Basketball World Cup Americas Pre-Qualifiers Second Round to be played in the same Summer than the FIBA AmeriCup.

The remaining teams shall not play any further in the qualification and shall play the FIBA AmeriCup Pre-Qualifiers during the FIBA Basketball World Cup Qualifiers cycle

- c. FIBA Basketball World Cup Americas Pre-Qualifiers Second Round
  - i. All teams that did not qualify for the FIBA Basketball World Cup Qualifiers through the FIBA AmeriCup Qualifiers (total of four [4] teams) and the four (4) highest-placed teams qualified from the FIBA Basketball World Cup Americas Pre-Qualifiers First Round shall be divided into two (2) groups of four (4).
  - ii. Each team shall play home and away games against the other teams in its group (a total of six [6] games per team). In the event that home and away games cannot be organised for logistical reasons, the affected groups shall play in tournaments hosted by one (1) of the participating teams according to the specific competition system approved by FIBA and the Regional Office.

    - i. The games shall be played in the windows defined in the FIBA Calendar.



- ii. For the FIBA Basketball World Cup European Pre-Qualifiers, the remaining registered teams that are not playing the FIBA EuroBasket Qualifiers, shall be divided into groups of four (4) or three (3) teams. Each team shall play home and away games against the other teams in its group (a total of six [6] or four [4] games for each team).
- iii. The four (4) highest-placed teams shall qualify for the FIBA Basketball World Cup European Pre-Qualifiers Second Round to be played in the same Summer than the FIBA EuroBasket.

All teams that did not qualify for the FIBA Basketball World Cup European Qualifiers through the FIBA EuroBasket Qualifiers (total of eight [8] teams) and the four (4) highest-placed teams qualified from the FIBA Basketball World Cup European Pre-Qualifiers First Round shall be divided into four (4) groups of three (3) teams.
  - ii. Each team shall play home and away games against the other teams in its group (a total of four (4) games per team). In the event that home and away games cannot be organised for logistical reasons, the affected groups shall play in tournaments hosted by one (1) of the participating teams according to the specific competition system approved by FIBA and the Regional Office.
  - iii. The two best-placed teams from each group (a total of eight [8] teams) shall play in the following FIBA Basketball World Cup Qualifiers.

The remaining teams shall not play any further in the qualification and shall play the FIBA EuroBasket Pre-Qualifiers during the FIBA Basketball World Cup Qualifiers cycle.

- 139. All registered National Member Federations from Africa shall play home and away games (or tournaments as applicable) during the International Window Periods established for the FIBA Basketball World Cup Qualifiers.
- 140. The sixteen (16) teams that participated in the previous FIBA AfroBasket shall play the FIBA Basket World Cup African Qualifiers. In case the Host of the FIBA Basketball World Cup is not among the sixteen (16) teams playing the previous FIBA AfroBasket, the Host shall participate in the FIBA Basketball World Cup African Qualifiers instead of the last-ranked team from the previous FIBA AfroBasket.
- 141. The following system of competition shall be applied for the FIBA Basketball World Cup Qualifiers.

#### First Round

# FIBA Basketball World Cup African Qualifiers

The sixteen (16) teams shall be divided into four (4) groups of four (4) teams (A, B, C and D). Each team shall play twice in two (2) tournaments against the other teams in its group (a total



of six (6) games per team). The two (2) tournaments will be organised in the first three (3) International Window Periods, which means that each of the teams will play in two (2) of the three (3) International Window Periods and will therefore have one (1) International Window Period during which they will not play.

A bidding process will be organised to allocate the organisation of each tournament. Fulfilment of the relevant criteria will be mandatory to host one (1) tournament. One (1) country may host the two (2) tournaments if the other teams are unable to do so.

For each group, one (1) tournament shall be played in International Window Period one (1) or International Window Period two (2); the second tournament shall be played in International Window Period three (3).

The three (3) highest placed teams from each group shall qualify for the second (2<sup>nd</sup>) round of the FIBA Basketball World Cup African Qualifiers.

The teams placed fourth in each group will not play further in the FIBA Basketball World Cup African Qualifiers.

# Qualifications for the FIBA Basketball World Cup

The twelve (12) teams qualified from the First Round shall be divided into two (2) groups of six (6) teams (E, F) as follows:

Group E: 1A, 2A, 3A, 1C, 2C, 3C
Group F: 1B, 2B, 3B, 1D, 2D, 3D

Each team shall play twice in two (2) tournaments against the three (3) new teams in its group (total of six (6) games per team). The results of all games played in the First Round (including the games played against teams not qualified for the Second Round) are carried over to the Second Round. In case one or more teams are withdrawn or disqualified during the First Round, their results will be nullified. In such a case, only the results of the games played against teams who qualified from the concerned First Round Groups to the second round will be carried over to the Second Round.

The two (2) tournaments will be organised in the last three (3) International Window Periods. For the sake of clarity, each team will play in two (2) of the three (3) International Window Periods and will therefore have one (1) International Window Period during which they will not play.

A bidding process will be organised to allocate the organisation of each tournament. Fulfilment of the relevant criteria will be mandatory to host one (1) tournament. One (1) country may host the two (2) tournaments if the other teams are unable to do so.

For each group, the first (1st) tournament shall be played in International Window Period four (4). The second (2nd) tournament shall be played in International Window Period six (6) for each group.

The two (2) best placed teams in each group and the best third placed team (total of five (5) teams) shall qualify for the FIBA Basketball World Cup.

# FIBA AfroCAN Qualifiers

All National Member Federations shall be invited to participate in the FIBA AfroCAN Qualifiers. The format of such FIBA AfroCAN Qualifiers shall be proposed by the FIBA Regional Offices in



Africa for FIBA Approval. Specific restrictions in terms of player participation in the FIBA AfroCAN Qualifiers shall be applied.

Games of FIBA AfroCAN Qualifiers shall be played during the International Window Periods.

The best twelve (12) teams of the FIBA AfroCAN Qualifiers shall qualify for the FIBA AfroCAN. The FIBA AfroCAN shall be played during the summer of the FIBA Basketball World Cup.

#### FIBA BASKETBALL WORLD CUP AMERICAS QUALIFIERS

- 142. All registered National Member Federations from Americas shall play home and away games during the International Window Periods for the FIBA Basketball World Cup Americas Qualifiers.
- 143. The best sixteen (16) teams shall play the FIBA Basketball World Cup Americas Qualifiers, while the remaining teams shall play the FIBA AmeriCup Pre-Qualifiers. The FIBA Basketball World Cup Americas Qualifiers shall be comprised of all twelve (12) teams that participated in the previous FIBA AmeriCup plus the four (4) best teams from the relevant qualification round.
- 144. The following system of competition shall be applied for the FIBA Basketball World Cup Americas Qualifiers.

## FIBA Basketball World Cup Americas Qualifiers

For the FIBA Basketball World Cup Americas Qualifiers, the sixteen (16) teams shall be divided into four (4) groups of four (4) teams (A, B, C, D). Each team shall play home and away games against the other teams in its own group (total of six (6) games per team).

The top three (3) teams from each group shall qualify for the Second Round of the FIBA Basketball World Cup Americas Qualifiers.

The teams placed fourth in each group shall play the FIBA AmeriCup Pre-Qualifiers to qualify for the FIBA AmeriCup Qualifiers.

## FIBA AmeriCup Pre-Qualifiers

The FIBA AmeriCup Pre-Qualifiers, all registered teams that are not playing for the FIBA Basketball World Cup Americas Qualifiers shall be divided into groups of four (4) or three (3) teams. Each team shall play home and away games against the other teams in its group (total of six (6) or four (4) games per team). In the event that home and away games are not possible to organise due to logistical or other reasons, these groups shall play tournaments hosted by one (1) of the participating National Member Federations according to the specific system of competition approved by FIBA.

The top four (4) best placed teams shall play the games to qualify for the FIBA AmeriCup Qualifiers for the following FIBA AmeriCup Cycle.

The remaining teams will not play further in the qualifications. In the following FIBA AmeriCup Cycle, they will play the FIBA Basketball World Cup Pre-Qualifiers.

The format of such FIBA Asia Cup Pre-Qualifiers second (2<sup>nd</sup>) round shall be proposed by the FIBA Regional Offices in Asia and Oceania for FIBA approval.

The eight (8) highest-placed teams of the FIBA Asia Cup Pre-Qualifiers second (2<sup>nd</sup>) round shall qualify for the following FIBA Asia Cup Division A cycle.

The remaining teams shall take no further part in the qualification and should play tournaments at Sub-Zones level during the following FIBA Asia Cup Qualifiers Cycle.

#### FIBA BASKETBALL WORLD CUP EUROPEAN QUALIFIERS

- 148. All registered National Member Federations from Europe shall play home and away games in the International Window Periods for the FIBA Basketball World Cup European Qualifiers.
- 149. The best thirty-two (32) teams (the twenty-four (24) teams that participated in the previous FIBA EuroBasket plus the eight (8) best teams from the relevant qualification round(s) shall play the FIBA Basketball World Cup European Qualifiers, whilst the remaining teams shall play in FIBA EuroBasket Pre-Qualifiers.
- 150. The following system of competition shall be applied for the FIBA Basketball World Cup European Qualifiers.

#### First round

## FIBA Basketball World Cup European Qualifiers

For FIBA Basketball World Cup European Qualifiers, the thirty-two (32) teams shall be divided into eight (8) groups of four (4) teams (A, B, C, D, E, F, G, and H). Each team shall play home and away games against the other teams in its group (total of six (6) games per team).

The three (3) best placed teams from each group shall qualify for the FIBA Basketball World Cup European Qualifiers of the FIBA Basketball World Cup Qualifiers.

The teams placed fourth in each group shall play in the Second and eventually the Third Rounds to qualify for the following FIBA EuroBasket Cup Qualifiers.

# FIBA EuroBasket Pre-Qualifiers

The four (4) best placed teams shall qualify for the Second Round.

194. The FIBA Olympic Qualifying Tournaments shall be held every four (4) years (2028, 2032, 2036 etc.).

# Participation in the FIBA Olympic Qualifying Tournaments

195. Twenty-four (24) teams, representing all continents, are eligible to participate in FIBA Olympic Qualifying Tournaments as follows:

- 196. In particular, these twenty-four (24) teams shall comprise the following:
  - a. The next best-ranked team from the previous FIBA Basketball World Cup from each of the following three (3) regions: Africa, Americas, and Asia-Pacific.
  - b. The sixteen (16) best placed teams not directly qualified for the Olympic Basketball Tournament from the previous FIBA Basketball World Cup, regardless of their continent of origin, will be invited to participate in the FIBA Olympic Qualifying Tournaments.
  - c. Five (5) additional teams will qualify directly from the FIBA Olympic Pre-Qualifying Tournaments as follows:

Africa: 1 team
Americas: 1 team
Asia-Pacific: 1 team
Europe: 2 teams

197. In the event a qualified team withdraws, is suspended or, in FIBA's sole determination, is not able for any reason to participate, FIBA has the right to invite the best non-qualified team in the FIBA World Ranking from the same continent to replace it. If the replacement team or a second qualified team are, in FIBA's sole determination, not able for any reason to participate, FIBA may issue an invitation to another team at its discretion and/or reduce the number of teams in the FIBA Olympic Qualifying Tournaments and adjust the competition format and schedule accordingly. This procedure may be applied more than once.

## System of competition

- 198. The system of competition of the FIBA Olympic Qualifying Tournaments is determined by the FIBA Central Board and is subject to final approval by the International Olympic Committee. In the event it deviates from the following articles, it shall be communicated to all concerned National Member Federations by FIBA.
- 199. The twenty-four (24) participating teams will be divided into four (4) tournaments of six (6) teams each.
- 200. Each tournament shall be hosted by one (1) of the six (6) participating National Member Federations.
- 201. The draw for the FIBA Olympic Qualifying Tournaments shall be made before the hosting National Member Federations are defined.
- 202. In principle, each continent shall host one (1) FIBA Olympic Qualifying Tournament.
- 203. The following System of Competition shall be applied for the FIBA Olympic Qualifying Tournament.

#### **Group Phase**

- a. The six (6) teams in each tournament are divided into two (2) groups (A, B) of three
  (3) teams each. Each team will play all the other teams in its own group (total of two
  (2) games for each team). A total of six (6) games will be played in the Group Phase of each tournament.
- b. The final standings of each group will be established after the Group Phase as follows:

Group A: 1A, 2A, 3A
Group B: 1B, 2B, 3B



c. The teams placed first and second in each group will play in the Semi-Finals; the teams placed third in each group will return home.

## FIBA WOMEN'S OLYMPIC PRE-QUALIFYING AND QUALIFYING TOURNAMENTS

204. The system of competition of the FIBA Women's Olympic Pre-Qualifying and Qualifying Tournaments is determined by the FIBA Central Board and is subject to final approval by the International Olympic Committee. In the event it deviates from the following articles, it shall be communicated to all concerned National Member Federations by FIBA.

# FIBA Women's Olympic Pre-Qualifying Tournament

- 205. The eight (8) teams that did not qualify to the FIBA Basketball World Cup 2026 via the FIBA Women's Basketball World Cup Qualifying Tournaments will qualify for the FIBA Women's Olympic Pre-Qualifying Tournament.
- 206. A National Member Federation that has been invited to participate in the FIBA Women's Olympic Pre-Qualifying Tournament must confirm their participation in the FIBA Women's Olympic Qualifying Tournament and the FIBA Women's Olympic Basketball Tournament to FIBA at the same time as registering their team for the FIBA Women's Olympic Pre-Qualifying Tournament by the relevant deadline communicated by FIBA.

- 208. The tournament shall be hosted by one (1) of the participating National Member Federations.
- 209. The following System of Competition shall be applied for the FIBA Women's Olympic Pre-Qualifying Tournament.

#### Group Phase

- a) There will be two (2) groups of four (4) teams each. Each team will play all the other teams in its own group (total of three (3) games for each team, and a total of twelve (12) games for the Tournament in the Group Phase).

- 213. The sixteen (16) teams shall be divided into four (4) tournaments of four (4) teams each.
- 214. The draw for the FIBA Women's Olympic Qualifying Tournaments shall be made before the hosting National Member Federations are defined. In order to implement the universality principle, at least one (1) of the tournaments shall contain two (2) teams of the same continent/geographical region, as decided by FIBA. The Host of the Women's Olympic Basketball Tournament and the winner of the latest edition of the FIBA Women's Basketball World Cup cannot be drawn in the same tournament.
- 215. Each tournament shall be hosted by one (1) of the participating National Member Federations.
- 216. In principle, each continent/geographic region should host one (1) FIBA Women's Olympic Qualifying Tournament.
- 217. In the event a qualified team withdraws, is suspended or, in FIBA's sole determination, is not able for any reason to participate, FIBA has the right to invite the best non-qualified team in the FIBA World Ranking from the same continent, to replace it. If the replacement team or a second qualified team are, in FIBA's sole determination, not able to participate for any reason, FIBA may issue an invitation to another team at its discretion and/or reduce the number of teams in the FIBA Women's Olympic Qualifying Tournaments and adjust the competition format and schedule accordingly. This procedure may be applied more than once.

## System of competition

- 218. The following system of competition shall be applied for the FIBA Women's Olympic Qualifying Tournaments:
  - a. The sixteen (16) participating teams will be distributed into four (4) groups (A, B, C and D) of four (4) teams each.
  - b. Each team will play all the other teams in its own group (total of three (3) games for each team).
  - c. The final standings of each group will be established after the Group Phase as follows:
    - Group A: 1A, 2A, 3A, 4A
    - Group B: 1B, 2B, 3B, 4B
    - Group C: 1C, 2C, 3C, 4C
    - Group D: 1D, 2D, 3D, 4D
- 219. The three (3) best placed teams from each tournament shall qualify for the Women's Olympic Basketball Tournament. For the tournament in which the winner of the latest edition of the FIBA Women's Basketball World Cup plays, the two (2) best placed teams and the winner of the FIBA Women's Basketball World Cup, shall qualify. In case the FIBA Central Board decides that the Host of the Women's Olympic Basketball Tournament shall directly qualify to the Women's Olympic Basketball Tournament, then the tournament in which the Host of the Women's Olympic Basketball Tournament plays, the two (2) best placed teams and the Host of the Women's Olympic Basketball Tournament, shall qualify.

# FIBA U19 & U17 BASKETBALL WORLD CUPS AND FIBA U19 & U17 WOMEN'S WORLD CUPS

- 221. The FIBA U19 Basketball World Cup and FIBA U19 Women's Basketball World Cup ("FIBA U19 Basketball World Cups") shall be held every two (2) years in odd-numbered years.
- 222. The FIBA U17 Basketball World Cup and FIBA U17 Women's Basketball World Cup ("FIBA U17 Basketball World Cups") shall be held every two (2) years in even-numbered years.
- 223. The provisions listed below shall be applied to all FIBA U19 World Cups and FIBA U17 World Cups (jointly "FIBA U19/U17 World Cups").
- 224. Sixteen (16) teams, representing all continents, are eligible to participate in the FIBA U19/U17 World Cups as follows:

A.	Directly Qualified

	Africa	2
	Americas	4
	Asia and Oceania	4
	Europe	5

- 225. The relevant qualifying competitions must be completed by 31 December of the year preceding the year of the Competition.
- 226. In the event a qualified team withdraws, is suspended or is otherwise unable to participate, FIBA has the right to invite the next best ranked team that has participated in the qualifying competitions. If the replacement team or a second qualified team are, in FIBA's sole determination, not able to participate for any reason, FIBA may issue an invitation at its discretion and/or reduce the number of teams in the FIBA U19/U17 World Cups and adjust the competition format and schedule accordingly. This procedure may be applied more than once.
- 227. Registration forms for participation in each of the FIBA U19/U17 World Cups shall be sent by FIBA to the qualified teams reasonably in advance prior to the starting date of the Competition.
- 228. National Member Federations must submit the duly completed registration forms by the deadline set by FIBA. In the event that a qualified team fails to meet this deadline, FIBA may revoke this National Member Federation's right to participate and replace it in accordance with article 2-226.
- 229. At the beginning of the Competition, the players' ages will be verified in accordance with the relevant provisions of Book 3 of these Internal Regulations and/or through any other method decided by FIBA.
- 230. The following system of competition shall be applied to the FIBA U19/U17 World Cups:

# **CHAPTER 8: FIBA CLUB COMPETITIONS**

- 232. FIBA Club Competitions extending beyond the geographic region of a continent (e.g. FIBA Intercontinental Cup) are governed by the respective competition regulations approved by the Central Board.
- 233. FIBA Club Competitions within the geographic region of a continent (e.g. Basketball Champions League Americas (BCLA), FIBA Europe Cup, WASL, Basketball Champions League Asia) are governed by the respective Zone Competitions Regulations approved by the Executive Committee.
- 234. Clubs registered with National Member Federations of FIBA are obliged, subject to the ordre public, to participate in FIBA Club Competitions if qualified through the applicable sporting criteria, unless otherwise provided for in the applicable competition regulations or decided by the competent Regional Office.
- 235. Clubs participating in FIBA Club Competitions are obliged to register and field their highest-level team with the strongest possible roster.
- 236. Clubs participating in FIBA Club Competitions may not have the same owner or otherwise have the same management or administration as another club participating in the same competition, unless decided otherwise by the competent Regional Office.

# **CHAPTER 9: FIBA-RECOGNISED COMPETITIONS**

- 237. The provisions of this Chapter 9 are subject to the provisions of the General Statutes and Internal Regulations governing Leagues and the Internal Regulations governing 3x3 competitions.
- 238. The FIBA Central Board shall apply objective criteria for the recognition by FIBA of international cups, games and tournaments.
- 239. International friendly games and tournaments between teams representing National Member Federations must be authorised by the National Member Federations concerned, including the National Member Federation of the country where the game or tournament is played.
- 240. The host(s) of the competition or the host National Member Federation may invite teams from any National Member Federation, on condition that the invited national federation is a FIBA National Member Federation and its affiliation is not suspended. Only teams officially recognised by their National Member Federation shall be allowed to participate in said competition.
- 241. Teams from a National Member Federation may not participate in any international competition in which a team from an entity not affiliated to FIBA is participating, unless prior written approval from FIBA has been obtained.
- 242. The hosts of the following multi-sport games are encouraged to seek the recognition of, and work in close cooperation with, FIBA in the organising and running of the basketball tournaments.
  - a. Continental or regional events such as the All-African Games, Pan-American Games, Asian Games, European Games, South-East Asian Games, Pacific Games, Commonwealth Games, Pan Arab Games, etc.; and
  - b. Specific interest events such as Universiade, Mediterranean Games, Francophonie Games, Lusofonia Games, World Masters Games, Maccabiah Games, World Military Games, etc.

In order to be recognized, these events must include 3x3 Basketball in their programs. The standalone inclusion of Basketball (i.e. the traditional format) in the program of any such event may be authorized in FIBA's sole discretion and may be subject to the acceptance of certain age-category restrictions as decided by the Central Board.

- 243. FIBA may charge an administrative/solidarity fee for its recognition.
- 244. In case recognition is granted by FIBA, the organiser and the host of the FIBA-Recognised Competition shall ensure that:
  - a. FIBA's technical requirements will be observed;
  - b. FIBA's player eligibility rules will apply;
  - c. FIBA will designate active FIBA Technical Delegates, Commissioners and Referees at the Host's costs;
  - d. FIBA will designate the FIBA Competitions Supervisor at the Host's cost to supervise the tournament(s); and



- e. The Host will respect other FIBA requirements, if any.
- 245. Participation in FIBA-Recognised Competitions shall not be subject to the provisions applying to participating in the FIBA National Team or FIBA Club Competitions, however:
  - a. Participants and host(s) of the competition shall observe the FIBA Official Basketball Rules:
  - b. The host of the competition, the host National Member Federation and all participants shall observe the FIBA Calendar:
  - c. The host of the competition, the host National Member Federation and all participants shall respect the FIBA General Statutes and Internal Regulations as per the FIBA Code of Conduct (see article 1-93), including without limitation FIBA's Code of Fair Play (articles 1-104 to 1-107) and FIBA's Code of Ethics and Integrity (articles 1-117 to 1-156), and in particular FIBA's regulations governing betting and corruption (articles 1-151 to 1-156) and act accordingly at all times on and off the court;
  - Players shall agree to submit at any time to medical tests and controls, particularly doping controls, carried out in compliance with the regulations of FIBA and WADA; and
  - e. The host of the competition or the host National Member Federation shall send a game/tournament report at the end of the game(s) or tournament(s). Upon request, FIBA will provide National Member Federations or third parties with the appropriate forms and deadlines. The host of the competition or the host National Member Federation shall use best efforts to use the Live Statistics software and provide the technical link to FIBA.
- 246. FIBA is competent to make any decision and to impose sanctions if the above provisions are not respected or if disciplinary offences occur during FIBA-Recognised competitions.



# **CHAPTER 10: FIBA ESPORT COMPETITIONS**

247. In accordance with its mission as set forth in Article 4 of the FIBA General Statutes, FIBA may develop, regulate, and promote FIBA eSport Competitions, as well as oversee the development of electronic or virtual disciplines of the sport of basketball ("eSport") worldwide.

# **CHAPTER 11: FIBA MASTERS COMPETITIONS**

248. In accordance with its mission as set forth in Article 4 of the FIBA General Statutes, FIBA may develop, regulate, and promote FIBA Masters Competitions, as well as oversee the development of age-group based tournaments for players aged between thirty-five (35) and seventy-five (75) years old worldwide.
