

INDIVIDUAL ENTRY FORM FIBA MASTERS OPEN HELLAS 2026 4-12 JULY 2026 (GREECE)

The undersigned individual (hereinafter the “**Participant**”) confirms that they (i) have already been duly registered for the FIBA Masters Open Hellas 2026 (hereinafter the “**Competition**”) in accordance with the applicable registration procedures; and (ii) are present at the Competition venue for the purpose of taking part in the Competition. This document is executed upon arrival at the Competition and constitutes an acceptance of the applicable terms and conditions of participation.

A. General Acknowledgements and Undertakings

The Participant hereby acknowledges and agrees:

- a. to accept the Competition format, schedule, and the results of the draw as determined by FIBA;
- b. to comply with all accreditations, medical, logistical, and administrative requirements of the Competition;
- c. to respect and comply at all times with the FIBA General Statutes, the FIBA Internal Regulations, the Official Basketball Rules, the Masters Handbook, any other Competition-specific regulations, and all related guidelines, circulars, and decisions (collectively, the “**Regulatory Framework**”);
- d. to participate in the Competition in accordance with the Regulatory Framework;
- e. to behave in a respectful and sports like manner, being responsible for their conduct throughout the Competition.

B. Forfeit and Withdrawal

Failure to participate, unjustified withdrawal, or non-attendance after arrival at the Competition may result in disciplinary and/or financial consequences in accordance with the Regulatory Framework, including the Masters Handbook and the FIBA Internal Regulations.

C. Media Rights Provisions

The Participant acknowledges and agrees that:

- a. FIBA is the exclusive owner of all worldwide audiovisual, broadcasting, television, and new media rights related to the Competition;
- b. FIBA may make available game footage to Participants through platforms or media designated by FIBA for technical or scouting purposes;
- c. Any footage recorded by the Participant or received from FIBA may be used exclusively for personal or internal technical purposes. Such footage may not be used for public, commercial, promotional, educational, or online publication purposes, nor at public events or clinics, without FIBA’s prior written consent.

D. Waivers and Jurisdiction

By signing this document, the Participant expressly and irrevocably agrees:

- a. to accept and be bound by the Regulatory Framework, including the FIBA General Statutes, the

FIBA Internal Regulations and the Masters Handbook;

- b. to accept the disciplinary process established in the Masters Handbook and submit any complaint not foreseen therein exclusively to the jurisdiction of the Court of Arbitration for Sport (CAS), Lausanne, Switzerland, in English, to the express exclusion of any ordinary court or other jurisdiction;
- c. to acknowledge and accept all risks inherent to participating in competitive basketball and to waive any claim against FIBA arising from health-related or physical impacts, in accordance with Article 2.4 of the Masters Handbook;
- d. to grant FIBA and its authorized partners the irrevocable, worldwide, and royalty-free right to use the Participant’s name, image, likeness, voice, and sporting performance for sporting, commercial, promotional, and/or broadcasting purposes, in any media and without limitation in time;
- e. to accept any further terms, conditions, consents, waivers, releases, and authorizations required in connection with participation in the Competition.
