

FIBA WOMEN'S BASKETBALL WORLD CUP PREDICTOR GAME

TERMS & CONDITIONS ("T&C")

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. Eligibility

The Basketball Predictor game (the "Game") is organised by the Fédération Internationale de Basketball ("FIBA"), a registered association under Swiss law. The Game is open globally to participants who register with a valid FIBA Basketball account. Anyone can participate, but only those who are at least 16 years old at the time of participation are eligible to win prizes. Employees of FIBA, their affiliates, subsidiaries, promotion agencies, and immediate family members are not eligible to win prizes. The Game is subject to Swiss laws and regulations. By participating, you agree to be fully unconditionally bound by these T&C, and you represent and warrant that you meet the eligibility requirements set forth herein. You also agree to accept FIBA's decisions as final and binding as they relate to the Game.

2. Game Period

The Game begins at the tip-off of the first game of the FIBA Women's Basketball World Cup 2026 on 04.09.2026 and ends following the conclusion of the final game on 13.09.2026. All predictions must be submitted before the scheduled start time of each game to be considered valid.

3. How to Participate

To participate, users must:

- Go on <https://www.fiba.basketball/en/events/fiba-womens-basketball-world-cup-2026/game-predictor>
- Register and log in with their FIBA Basketball account.
- Predict the winner of each game and the margin of victory before each game starts.

Predictions can be edited any time before the game starts. Once the game begins, the predictions are locked.

4. Scoring and Prizes

Points are awarded as follows:

- Correct winner: 3 points
- Correct winner and correct victory margin bracket: 5 points total

No points will be awarded in case of a forfeited game.

Leaderboard prizes:

1st Place: Sony PlayStation 5, NBA 2K27 Game Code & Molten Official Game Ball

2nd Place: Premium NIKE Basketball Shoes (or equivalent voucher) & Molten Official Game Ball

3rd Place: Molten Official Game Ball & €200 Women's World Cup Merchandise Voucher

5th Place: €150 Women's World Cup Merchandise Voucher

6th Place: €100 Women's World Cup Merchandise Voucher

7th Place: €100 Women's World Cup Merchandise Voucher

8th Place: €100 Women's World Cup Merchandise Voucher

9th Place: €50 Women's World Cup Merchandise Voucher

10th Place: €50 Women's World Cup Merchandise Voucher

Prizes are non-transferable and not redeemable for cash.

Winners will be contacted by email and must respond within 48 hours to claim their prize.

Winners may be required to confirm their eligibility and provide identification.

Merchandise vouchers are redeemable in the official Women's Basketball World Cup merchandise store (subject to applicable terms and availability).

In case a prize item becomes unavailable, an equivalent alternative of similar value may be provided.

5. Winner Selection and Notification

Winners will be determined by their total score on the global leaderboard. In case of a tie, the following tie-breakers apply:

- 1- Most "Perfect Predictions" (most correct "Winner + Margin")
- 2- Fewest Incorrect Predictions
- 3- Streak of Perfect Predictions (Longest consecutive streak of perfect predictions)
- 4- "Clutchness" (The last 5 games overall points to rank players)

In the event of a tie at the conclusion of the tournament, FIBA reserves the right to randomly select the Prize winner from among the highest-ranked participants.

6. Management of the Game

FIBA reserves the right to cancel, terminate, modify or suspend the Game at its sole discretion should it be affected by technical or other issues beyond FIBA's control. FIBA also reserves the right to disqualify any participant who tampers with the Game or breaches these T&C.

7. Integrity

FIBA shall ensure the integrity of the Game by invalidating suspicious entries, including those made via bots, scripts, or multiple accounts.

8. Limitation of Liability

By entering, participants agree to release and hold harmless FIBA and its agents from any liability arising from participation or prize use, including technical failures or unauthorized human intervention.

9. Disputes

The Game is governed by Swiss law. All disputes shall be resolved individually and exclusively in a court located in Switzerland.
