Who can access MAP?

- Only registered users can access MAP
- An existing national federation (NF) user who already has a valid MAP account and access rights to manage the *Game Officials Licensing Registration* can login and access the new GOL2025-2027 registration.
- NF that does not have a registered MAP user or wish to change a MAP user must submit an *NF User Request Form*.



- ▶ If a NF does not have a registered user they must submit the NF User Request Form.
 - ▶ The form is provided in the GOL2025-27 info package for national federations and is also available in MAP

- ▶ The form must be undersigned:
 - ▶ Firstly, by President or Secretary General of the NF
 - ▶ Secondly, by the Regional Office to which the NF belongs

- ▶ After the approval, FIBA MAP Support Team will grant access to a new NF user.
